## 2023 ANNUAL MEETING & ELECTIONS

According the RCT By-Laws, the membership must be notified of the annual election of Officers and Trustees at least 30 days prior to the meeting. The meeting is scheduled for Tuesday May 16 at 7:30 PM; all members are eligible to vote and new members may join at the meeting as well. The Nomination Committee (Janet Hanna, Nancy Novak, John Parker, Elizabeth Saunders and Barb Seaton) has submitted the following slate of people who have indicated their plans to run for either an Officer position or a 3-year term as a Trustee. In addition to those endorsed by the committee, nominations from the floor are always an option.

Please take a moment to get to know the people who are interested in the governance of YOUR community theater.

President—Stephen Hampe: In my past two years as a board officer (Secretary then 1st VP) I have gained exposure and perspective regarding the operations and challenges facing the organization. It is my intention to continue and amplify my predecessor's devotion to expanding RCT's reach as a welcoming and vibrant contributor to Rome's arts community, providing an outlet to a diverse community of creatives and an engaging source of entertainment, presenting a robust mix of classic and contemporary productions, including regular programming designed to bring a younger volunteer pool to our community. In support of that mission, I seek to continue the modernization of our administrative infrastructure in service of preserving the history of the organization, management of its day-to-day functioning, and outreach to the local community.
